WORLD BLANKET PROGRAM 5/17

Next Sunday, DUC will participate in the Church World Service Blanket Program. We do this every year on Mother’s Day because we feel it is an especially nice day to pledge the gift of warmth and care in honor or memory of someone who has taken care of you. The Missions Committee will place envelopes in the pews next week for cash or check donations and will have a table in Fellowship Hall after the service. They will have cards for you to send to the person you are honoring, if you’d like. Church World Service distributed about 6,500 blankets last year through this program; around 4,300 were distributed in the United States. Just \$10 covers the gift of one CWS blanket; \$50 would provide blankets for a family of 5.

Another reason why it's important to buy D-YECH Food cards: D came to HAC seeking assistance with her rent arrearage. D was recently laid off and missed a few weeks of pay, and the housing for herself and her 18 year-old daughter was at risk. She was lucky enough to get rehired under a different department that had funding to keep her but at a lower rate of pay. She also had some car issues that needed to be addressed over the winter as well. I called her apartment building, where she has lived for fifteen years, and asked about her tenancy. They quickly stated that D always "works her butt off and does whatever she has to in order to get the rent paid." We utilized \$500 from Private

Prevention Funds to be used towards her rent arrearage.
